### Results of Operations

For the period ended June 30, 2023, the Fund had total returns of 6.8% (Series A), 7.5% (Series F2), and 7.4% (Series F), and 7.2% (Series D).

The Canadian bond market, as represented by the FTSE Canada Universe Bond Index, finished up 2.5% for the 6-month period ending June 30, 2023 as inflation remained stubborn across most global markets. The 10-year Government of Canada yield was volatile during the period, driven early on by contagion concerns over regional bank collapses in the U.S., though was relatively range-bound between 2.7% and 3.5% and finished the period basically flat at 3.3%. The Bank of Canada raised its policy rate by 25bps in January, paused its rate hiking schedule in March and April, before raising rates again in early June as inflation concerns refused to go away.

The Canadian equity market ended the 6-month period in positive territory as the S&P/TSX Composite Index returned 5.7%. The major theme for the first half of 2023 was combating inflation by Canada's central bank. Over the same period, Global equities advanced as the MSCI World Index (C\$) returned 12.6%. Tight monetary conditions and the rising odds for a potential recession were key headwinds facing the global economy over this period; however, a small concentration of mega cap stocks led to strong equity returns.

Inflation remained the dominant economic issue over the period. Many central banks continued to tighten monetary policy by raising interest rates or tapering their asset purchase programs to curb inflation. This has marked a deceleration in the CPI for most major economies; a major contributor was also the decline in oil prices from \$80 U.S. dollars to around \$71 U.S. dollars a barrel. Central banks continue to face the delicate task of balancing the need for economic stimulus with the risk of elevated prices. Nonetheless, the U.S. Federal Reserve (Fed), the European Central Bank (ECB) and the Bank of England (BoE) have not reached their target inflation rate of 2%, all three major central banks have hinted they are not done raising interest rates. In Canada, we witnessed inflation dip from 6.3% in December 2022 to 2.8% in June. The slowdown was largely attributed to a decline in gasoline prices and an ease in supply chain bottlenecks. The result was broadly in line with the Bank of Canada's (BoC) baseline scenario that inflation will slow to the 3% mark by summer, raising doubts over the extent of rate hikes left in its tightening campaign. The BoC has raised interest rates only twice for the period closing at 4.75% - hitting a 15-year high in Canada. Though it has not reached its target inflation rate of 2%, Canada's central bank has also hinted it is not done raising interest rates.

In Canada, ten of the 11 GICS (Global Industry Classification Standard) sectors posted positive returns over the 6-month period. The best performing sectors were Information Technology (47.5%), Consumer Discretionary (+11.3%), and Industrials (+8.7%). The worst performing sectors in Canada were Energy (-2.3%), Materials (0.6%), and Health Care (1.3%). Seven of the eleven MSCI World Index (C\$) GICS (Global Industry Classification Standard) sectors posted positive returns over the 6-month period, with Information Technology, Communication Services and Consumer Discretionary being the largest contributors to index returns. The worst performing sectors were Energy, Utilities and Health Care.

The Fund's exposure to liquid alternatives continued to provide risk diversity to the Fund. The equity oriented MD Strategic Opportunities Fund, Series I, had a positive return over the of the first half of the year; however, the global exposure of the Fund detracted as the Canadian Dollar appreciated relative to the US Dollar reducing some of the returns. The allocation to alternative fixed income held within the MD Strategic Yield Fund also contributed positively year-to-date through June.

At the end of June, the Fund held a defensive tactical exposure being underweight equities, as well as a regional overweight to US equities, relative to an underweight to International and Emerging Market stocks. Surprisingly strong economic data from the US, along with continued positive sentiment from investors provides support for the region; however, expectations for weaker global growth amid elevated valuation and stubbornly high inflation warrants a defensive tactical position.

As at June 30, 2023, the total net asset value of the Fund was \$404.07 million, an increase of 6% since the beginning of the year. The increase is due to net investment gain, partially offset by net redemptions.

### Recent Developments

#### STRATEGIC CHANGES

There have been no strategic changes and the Fund continues to be managed in a manner consistent with its investment mandate and is positioned to achieve its long-term objectives. The Investment Advisers have adhered to their investment disciplines and portfolio strategies.

### Related Party Transactions

MD Financial Management Inc. is the Manager, Registrar and Trustee of the Fund. As Manager, MD Financial Management Inc. manages the overall business of the MD Family of Funds and the MDPIM Pools (collectively "the Funds") and is responsible for: setting investment objectives, providing and/or retaining the services of third party service providers for fund accounting services, administration services, and promoting the sales of the Fund's units.

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia (Scotiabank).

1832 Asset Management LP, a subsidiary of Scotiabank, is the portfolio manager of the Funds. MD Financial Management Inc., as Manager, continues to have overall responsibility for the management of the Funds. MD Financial Management Inc. is the registered portfolio manager and provides the discretionary portfolio management services to managed-account clients through MD Private Investment Counsel. 1832 Asset Management LP is responsible for the overall performance of the Funds, the management of fund assets and the selection and monitoring of the Funds' sub-advisors.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

As Registrar, MD Financial Management Inc. keeps track of the owners of units of the Fund, processes purchase, transfer and redemptions orders, issues investor account statements and issues annual tax reporting information.

As the Fund is organized as a Trust, investing in the Fund means purchasing units of the Trust. As Trustee to the Fund, MD Financial Management Inc. holds actual title to the property in the Fund—the cash and securities the Fund invests in—on behalf of the unitholders.

The principal distributor is MD Management Limited. As principal distributor, MD Management Limited markets the units of the Fund through its offices across Canada. MD Management Limited is a wholly owned subsidiary of MD Financial Management Inc.

### INDEPENDENT REVIEW COMMITTEE

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members: Stephen J. Griggs (Chair), Simon Hitzig, Heather A.T. Hunter, Jennifer L. Witterick and Steven Donald each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders, as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. The compensation for the IRC is an annual flat fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager is required to advise the IRC of any breach of a condition of any standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of its management of the Fund relied on IRC standing instructions regarding related party transactions as set out below:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Purchases of securities of a related party;
- Investment Advisor Monitoring and Oversight

### Management Fees

MD Financial Management Inc. provides the Fund with investment management and administrative services, including fund accounting and unitholder record-keeping. In return, MD Financial Management Inc. receives an annual management fee and an annual administration fee, both based on a fixed percentage of the daily net asset value of the Fund. Management fees are paid weekly and administration fees are paid monthly.

MD Financial Management Inc. pays MD Management Limited, a related party, a fee for providing financial planning services to Series A unitholders. The estimated breakdown of the services received in consideration of the management fee for Series A is as follows:

Series F and F2 unitholders pay a separate managed account fee directly to MD Management Limited. 100% of the management fee on Series F, Series F2 and Series D is for investment management and other services.

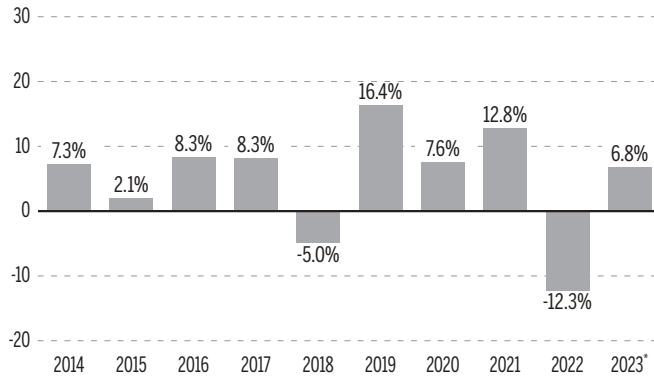

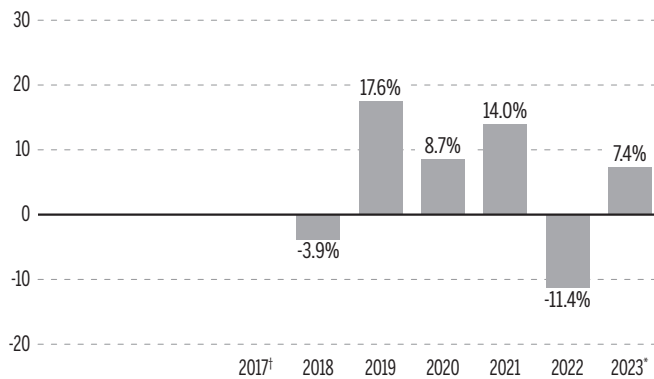
### YEAR-BY-YEAR RETURNS

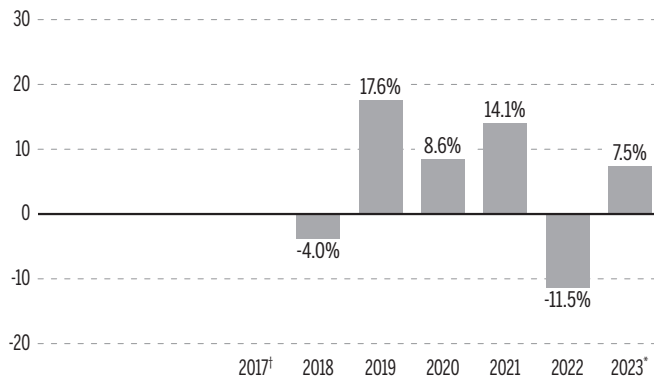

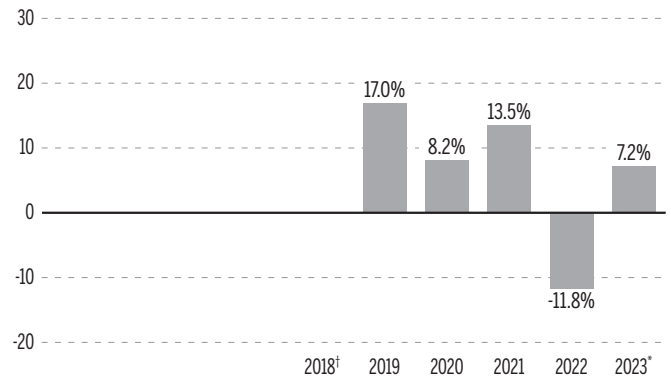
#### Series F2
