Results of Operations

For the period ended June 30, 2024, the Fund had total returns of 14.3% (Series A), 14.5% (Series I), 13.8% (Series D), and 14.0% (Series F).

Emerging market equities participated in the strength in global equity markets with the MSCI Emerging Markets Index (C\$) having returned 11.7% over the past 6-month period. This return lagged that of the US (S&P 500) but outperformed that of developed international markets (MSCI EAFE) and Canadian equities (S&P/TSX Composite).

China continues to suffer from continued weakness in the housing sector which kept confidence low as individuals focus on deleveraging. Chinese CPI is no longer falling year on year but remains depressed reflecting the weak demand in the economy. Despite the weak economic environment, Chinese equities gained over 11% in Canadian dollar terms over the 6-month period. However, this gain underperformed the aggregate return of emerging markets, with markets such as Taiwan, India and Turkey returned over 20% in CAD terms. Latin American equities were a laggard, due to weakness in local markets and their currencies, over concerns with political stability in markets such as Brazil and Mexico.

The Fund's regional allocations were mostly focused in East Asia, China, Taiwan and Korea which represent almost half of the fund on average over the period. The next largest market allocations are to India, Brazil and Mexico which combined over 20% on average for the 6-month period. The remaining country allocations in the Fund are split across the remaining emerging markets as well as select multi-nationals that derive a significant part of their revenue from emerging markets. In terms of contribution to return, Taiwan, India, Korea and China were the strongest positive contributors to return due to strong returns and significant weights. Brazil, Mexico and Indonesian equities had the most significant negative impact on return.

Nine of the 11 sectors represented in the portfolio contributed positively to the Fund's return in Canadian dollar terms. Information Technology, Industrials and Financials were the three biggest positive contributors to return due to their large weight and strong returns. Materials and Consumer Staples were the only sectors to have a negative contribution to return for the period, although the negative impact was modest.

The Fund's active multi-manager structure combines complementary investment approaches. Over the period there were no material changes to the Pool's overall sector or regional positioning.

As at June 30, 2024, the total net asset value of the Fund was \$2.07 billion, an increase of 8% since the beginning of the year. The increase is due to net investment gain offset by net redemptions.

Recent Developments

STRATEGIC CHANGES

There have been no strategic changes and the Fund continues to be managed in a manner consistent with its investment mandate and is positioned to achieve its long-term objectives. The Investment Advisers have adhered to their investment disciplines and portfolio strategies.

Related Party Transactions

MD Financial Management Inc. is the Manager, Registrar and Trustee of the Fund. As Manager, MD Financial Management Inc. manages the overall business of the MD Family of Funds and the MDPIM Pools (collectively "the Funds") and is responsible for: setting investment objectives, providing and/or retaining the services of third party service providers for fund accounting services, administration services, and promoting the sales of the Fund's units.

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia (Scotiabank).

1832 Asset Management LP, a subsidiary of Scotiabank, is the portfolio manager of the Funds. MD Financial Management Inc., as Manager, continues to have overall responsibility for the management of the Funds. MD Financial Management Inc. is the registered portfolio manager and provides the discretionary portfolio management services to managed-account clients through MD Private Investment Counsel. 1832 Asset Management LP is responsible for the overall performance of the Funds, the management of fund assets and the selection and monitoring of the Funds' sub-advisors.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

As Registrar, MD Financial Management Inc. keeps track of the owners of units of the MDPIM Pools, processes purchase, transfer and redemption orders, issues investor account statements, and issues annual tax reporting information.

As the Fund is organized as a Trust, investing in the Fund means purchasing units of the Trust. As Trustee to the Fund, MD Financial Management Inc. holds actual title to the property in the Fund—the cash and securities the Fund invests in—on behalf of the unitholders.

Units of the MDPIM Pools are only available to clients of MD Private Trust Company or discretionary managed account clients of MD Financial Management Inc. MD Management Limited ceased to be the principal distributor of the MDPIM Pools as effective October 29, 2018, except for Series I, Series F and Series D units of this Pool are available through accounts held at MD Management Limited, which acts as principal distributor in respect of those units. MD Management Limited is a wholly owned subsidiary of MD Financial Management Inc.

INDEPENDENT REVIEW COMMITTEE

The Manager has established an independent review committee (the "IRC") in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds ("NI 81-107") with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager's decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81–107.

The IRC may also approve certain mergers between the Fund and other funds and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

Management Report of Fund Performance (June 30, 2024)

The IRC has four members: Stephen J. Griggs (Chair), Heather A.T. Hunter, Jennifer L. Witterick and Steven Donald each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders, as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager's website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. The compensation for the IRC is an annual flat fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager is required to advise the IRC of any breach of a condition of any standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager's written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of its management of the Fund relied on IRC standing instructions regarding related party transactions as set out below:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- · Purchases of securities of a related party;
- · Investment Advisor Monitoring and Oversight

Management Fees



Past Performance




YEAR-BY-YEAR RETURNS



Series I




Series F



⁴ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.
