### Results of Operations

For the period ended June 30, 2023, the Fund had total returns of 9.5% (Series A), and 9.3% (Series F).

International equities advanced over the 6-month period as the MSCI EAFE Index (C\$) returned 9.5%. Despite tight monetary conditions economic data proved resilient. Better than expected economic data and signs of moderating inflation reduced the market's fears over a possible recession, which supported equity markets.

Inflation remained the dominant economic issue over the period. Many central banks continued to tighten monetary policy by raising interest rates or tapering their asset purchase programs to curb inflation. This has marked a deceleration in the CPI for most major economies; a major contributor was also the decline in oil prices from \$80 U.S. dollars to around \$71 U.S. dollars a barrel. Central banks continue to face the delicate task of balancing the need for economic stimulus with the risk of elevated prices. Nonetheless, the U.S. Federal Reserve (Fed), the European Central Bank (ECB) and the Bank of England (BoE) have not reached their target inflation rate of 2%, all three major central banks have hinted it is not done raising interest rates.

With the battle against inflation showing signs of success and consumption and labour data proving resilient, the odds placed on a soft landing scenario have improved. This combined with a rally in technology shares, in part driven by enthusiasm over AI, helped support investor sentiment.

The Fund's regional allocations were split between Europe and Asia-Pacific. European equities, including the UK, represented the largest allocation, approximately 60% the portfolio by market value, on average. European equities were the largest positive contributors to return, however, all regions except for Australia were negative for the period. Currency had a modestly negative impact on return for the period, as the Japanese yen and European currencies such as the euro, British pound sterling, and Swedish krona all depreciated versus the Canadian dollar.

Nine of the 11 sectors represented in the portfolio contributed positively to the Fund's return in Canadian dollar terms. Industrials, Consumer Discretionary and Information Technology were the three biggest positive contributors to return due to their large weight and strong returns. In contrast, the Real Estate and Energy sector were the only two sectors to experience a negative return for the period. Energy prices fell weighing on that sector while Real Estate continues to struggle with structural changes in that market related to work from home, as well as higher interest rates.

The Fund is passively managed to match the benchmark index. All positioning and changes thereto are a function of changes in the index composition.

As at June 30, 2023, the total net asset value of the Fund was \$1.02 billion, a decrease of 7% since the beginning of the year. The decrease is due to net investment loss and income distributions to unitholders, partially offset by net contributions.

### Recent Developments

#### STRATEGIC CHANGES

There were no strategic changes to the Fund. The Fund's core investment philosophy is to seek diversification through balanced exposure to securities in the International equity market.

### Related Party Transactions

MD Financial Management Inc. is the Manager, Registrar and Trustee of the Fund. As Manager, MD Financial Management Inc. manages the overall business of the MD Family of Funds and the MDPIM Pools (collectively "the Funds") and is responsible for: setting investment objectives, providing and/or retaining the services of third party service providers for fund accounting services, administration services, and promoting the sales of the Fund's units.

The Manager is a wholly-owned subsidiary of The Bank of Nova Scotia (Scotiabank).

1832 Asset Management LP, a subsidiary of Scotiabank, is the portfolio manager of the Funds. MD Financial Management Inc., as Manager, continues to have overall responsibility for the management of the Funds. MD Financial Management Inc. is the registered portfolio manager and provides the discretionary portfolio management services to managed-account clients through MD Private Investment Counsel. 1832 Asset Management LP is responsible for the overall performance of the Funds, the management of fund assets and the selection and monitoring of the Funds' sub-advisors.

The Manager, on behalf of the Fund, may enter into transactions or arrangements with other members of Scotiabank or certain other companies that are related or connected to the Manager (each a "related party"). All transactions between the Fund and the related parties are in the normal course of business and are carried out at arm's length terms.

As Registrar, MD Financial Management Inc. keeps track of the owners of units of the MDPIM Pools, processes purchase, transfer and redemption orders, issues investor account statements, and issues annual tax reporting information.

As the Fund is organized as a Trust, investing in the Fund means purchasing units of the Trust. As Trustee to the Fund, MD Financial Management Inc. holds actual title to the property in the Fund—the cash and securities the Fund invests in—on behalf of the unitholders.

Units of the MDPIM Pools are only available to clients of MD Private Trust Company or discretionary managed account clients of MD Financial Management Inc. MD Management Limited ceased to be the principal distributor of the MDPIM Pools as effective October 29, 2018, except for Series F units of the Pools which are available through accounts held at MD Management Limited, which acts as principal distributor in respect of those units. MD Management Limited is a wholly owned subsidiary of MD Financial Management Inc.

### INDEPENDENT REVIEW COMMITTEE

The Manager has established an independent review committee (the “IRC”) in accordance with National Instrument 81-107 – Independent Review Committee for Investment Funds (“NI 81-107”) with a mandate to review and provide recommendations or approval, as required, on conflict of interest matters referred to it by the Manager on behalf of the Fund. The IRC is responsible for overseeing the Manager’s decisions in situations where the Manager is faced with any present or perceived conflicts of interest, all in accordance with NI 81-107.

The IRC may also approve certain mergers between the Fund and other funds and any change of the auditor of the Fund. Subject to any corporate and securities law requirements, no securityholder approval will be obtained in such circumstances, but you will be sent a written notice at least 60 days before the effective date of any such transaction or change of auditor. In certain circumstances, securityholder approval may be required to approve certain mergers.

The IRC has five members: Stephen J. Griggs (Chair), Simon Hitzig, Heather A.T. Hunter, Jennifer L. Witterick and Steven Donald each of whom is independent of the Manager.

The IRC prepares and files a report to the securityholders each fiscal year that describes the IRC and its activities for securityholders, as well as contains a complete list of the standing instructions. These standing instructions enable the Manager to act in a particular conflict of interest matter on a continuing basis provided the Manager complies with its policies and procedures established to address that conflict of interest matter and reports periodically to the IRC on the matter. This report to the securityholders is available on the Manager’s website or, at no cost, by contacting the Manager.

The compensation and other reasonable expenses of the IRC will be paid out of the assets of the Fund as well as out of the assets of the other investment funds for which the IRC may act as the independent review committee. The compensation for the IRC is an annual flat fee. Expenses of the IRC may include premiums for insurance coverage, travel expenses and reasonable out-of-pocket expenses.

The Manager is required to advise the IRC of any breach of a condition of any standing instructions. The standing instructions require, among other things, that the investment decision in respect to a related party transaction: (a) is made by the Manager free from any influence by an entity related to the Manager and without taking into account any consideration to any associate or affiliate of the Manager; (b) represents the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; and (c) is made in compliance with the Manager’s written policies and procedures. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC to monitor compliance.

The Manager, in respect of its management of the Fund relied on IRC standing instructions regarding related party transactions as set out below:

- Paying brokerage commissions and spreads to a related party for effecting security transactions on an principal basis on behalf of the Fund;
- Purchases or sales of securities of an issuer from or to another investment fund managed by the Manager;
- Investments in the securities of issuers for which a related underwriter acted as an underwriter during the distribution of such securities and the 60-day period following the completion of such distribution;
- Purchases of securities of a related party;
- Investment Advisor Monitoring and Oversight

### Management Fees

No management fee is charged in respect of Series A units of the Fund. Investors in these units have agreed to pay a managed account fee directly to MD Financial Management Inc.

Series F unitholders pay a separate managed account fee directly to MD Management Limited. 100% of the management fee on Series F is for investment management and other services.

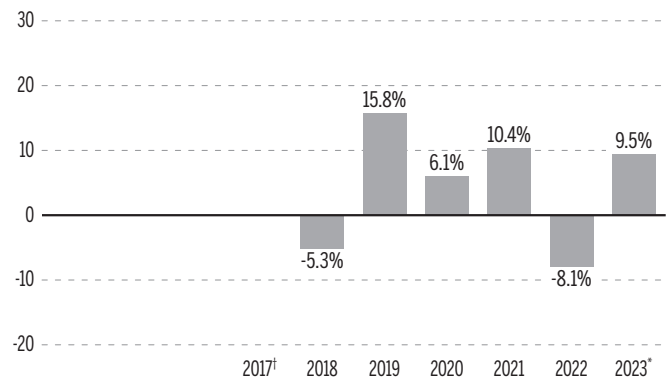
### Past Performance

#### YEAR-BY-YEAR RETURNS

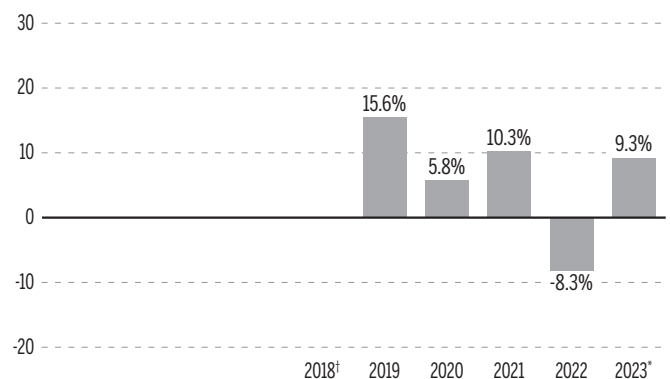

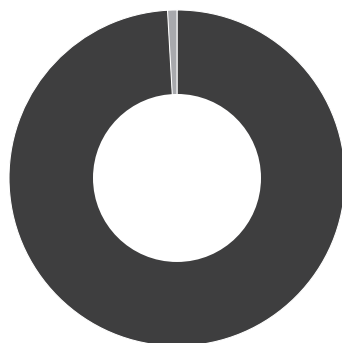
